Request for urgent intervention to stop the deportation of the Ms.

Hashina Begam, a Rohingya refugee staying in India

Dear Sir,

Human Rights Alert (HRA) has come to know from reliable sources that one Ms. Hashina Begam a Rohingya refugee staying in India is scheduled to be deported to the Myanmar tomorrow 22 March 2022 from Moreh in Tengnoupal District, Manipur. She is reportedly picked up from the holding centre in Jammu at Kathuwa Sub-Jail by the Government authorities on 15 March 202. Her husband and three minor children are still living in the holding shelters in Jammu.

Considering the political turmoil that is going on inside Myanmar, the persecution that the Rohingya community suffers from the authority as well as the fact that the lady is separated from her immediate family who are still in Jammu, it is highly unsafe for Hasina to be deported back to Myanmar at this point in time.

HRA humbly request the Hon'ble Commission to kindly make prompt intervention to stop the deportation as it violates not only the Principle of Non Refoulement enshrine in Article 14 of the Universal Deceleration of Human Rights but also the right to life which is a fundamental right guaranteed to all persons by Article 21 of the Constitution of India.

Thanking you in anticipation for the prompt and immediate action of the Hon'ble Commission for this very urgent matter.

Proceeding is taken up on complaint petition dated 21.3.2022 being filed by Human Right Alert through its Executive Director namely Babloo Loitongbam.

By this complainant petition complaint prays for this Commission's intervention to stop the deportation of one Ms. Hasina Begam, a Rohingya refugee who, through staying in India, is alleged to be planning to be deported to Myanmar tomorrow 22nd March 2022 from Moreh in Tengnoupal District, Manipur. The complaint petition is examined and also heard complainant in person.

The complaint petition *prima facie* shows a violation of the right to life/ personal liberty guaranteed by the Constitution of India read with Article 14 of the *Universal Declaration of Human Right* and the



doctrine of non-refoulment.

Hence, register it as MHRC Complaint Case under Section 12 of the PHR Act, 1993.

Ask Special Secretary (Home) Government of Manipur, DGP Manipur and SP Tengnoupal District to put on hold the alleged plan for deportation if true, of the said Ms. Hashina Begam to Myanmar from Moreh, Tengnoupal District which is within the territorial jurisdiction of this Commission.

Fix 24.3.2022 for respondents' action taken report without fail for further necessary recommendation.

Kindly refer to PHQ letter No. 15/15/2022/HR/PHQ/79 dated 23.03.2022 on the above cited subject. In this regard I am to furnish herewith the following report for kind information and taking necessary action.

- (1)This office was intimated by the Sr. Superintendent of Police, CID Counter Intelligence, Jammu via email vide letter No. CIJ/Index/Myanmar/2022/3482 dated 10/03/2022 (copy enclosed as Annexure-A) that a team of Jammu & Kashmir Police would be departing Jammu by Rajdhani Express train on 15.03.2022 and was scheduled to reach Dimapur Railway Station on 17/18.03.2022 for repatriation of 1 (one) Myanmar national namely, Hasina Begum, d'o Kalil Mohammad, r/o Toung Brung, Moung Daw, Myanmar through Indo-Myanmar Friendship Gate No. 2, ICP, Moreh on 22.03.2022. He requested SP/CID(SB), Manipur to arrange transport for the escort party of Jammu & Kashmir Police, comprising of 8 (eight) officials and the Myanmar national from Imphal to Moreh (to and fro) and their lodging during their stay in the state. He had also requested to liaise with the authorities at Indo-Myanmar Friendship Gate No. 2, ICP, Moreh for smooth repatriation of the above mentioned Myanmar national on 22.03.2022.
- (2) The request for Jammu & Kashmir Police was forwarded to PHQ (for arrangement of transport and escort), the Senior Immigration Officer, ICP, Moreh (for repatriation) and the Addl.SP, Moreh (for accommodation) on 14.03:2022 (copies enclosed as Annexure - B, C, D).
- (3) The Jammu & Kashmir Police team reached Imphal on 18.03.2022 in a private vehicle hired from Dimapur and they proceeded to Moreh on the same day in the same vehicle.
- (4) The Myanmar national was received by the District Immigration Officer, Tamu as proposed on 22.03.2022 and the escort party of Jammu & Kashmir Police returned to Imphal on 22.03.2022 along with the escort team of Manipur Police detailed by PHQ. They halted 22.03.2022 at a hotel in Imphal and left for Dimapur Railway Station in the morning of 23.03.2022 by a private vehicle.
