## Introduction

Embedded within the complex fabric of India's socio-environmental challenges, the Forest Rights Act (FRA), officially known as the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 stands as a transformative landmark. Enacted 17 years ago, the FRA represents a dedicated effort to address historical injustices against Adivasi and other forest dwelling communities, both during the colonial era and in the post-Independence period. Beyond a mere legal framework, the FRA embodies a democratic and grassroots-driven model of forest governance.

Building upon a similar exercise conducted in 2019, the objective of this research is to assess the Forest Rights Act's minimum potential in advancing the rights of Adivasi and other forest dwelling communities to their forests and resources against the backdrop of the upcoming 2024 Parliamentary General Elections. Regrettably, 17 years since its inception the implementation of the Act has consistently fallen short.

This lapse in implementation underscores a lack of political will to address the issue of forest tenure rights and justice for the Scheduled Tribe Communities and Other Traditional Forest Dwellers (OTFDs) through effective implementation of the FRA. There exists a pervasive disregard for the profound connection Adivasi and forest dwelling communities share with the forest, coupled with an increasing shift in the policy direction towards commercial extraction of forests. This disregard has systematically led to the undermining of the constitutional rights embedded in the Forest Rights Act.

Unfortunately, the FRA remains poorly implemented in most states, plagued by a lack of political will and vehement opposition from the forest bureaucracy. Estimates suggest that at least 30 million hectares of forest land, comprising more than 40% of the total forest area, could be vested as Community Forest Rights (CFRs) with Gram Sabhas. This has the potential to secure the rights and livelihoods of at least 200 million people, including nearly 90 million tribals. Approximately one-fourth of the villages in the country i.e. 1,75,000 are eligible for CFR rights. Most districts with a high number of eligible villages are situated in tribal-majority and poverty-stricken regions, often entangled in conflicts over land and resources.

Ground-level evidence demonstrates that rights holders have utilized the FRA, particularly its community forest rights provisions, for transforming forest management to meet local livelihood and cultural needs, ensuring food security and poverty alleviation, securing gender justice and women's rights over land and forest, and strengthening conservation efforts to meet India's international commitments for climate change mitigation.

As we approach the threshold of the 2024 general elections, this research exercise, estimating the minimum potential of the FRA for recognition of forest rights in the parliamentary constituencies offers critical information for political parties and forest rights groups to advance the agenda of forest rights recognition as per FRA in the upcoming election and address the major issues affecting implementation of FRA- forest rights of STs and OTFDs in the potential constituencies. It is a reminder of our nation's responsibilities to its most marginalised and excluded citizens and an invitation to engage in a more just and equitable India.

## Methodology

This note has been computed using two Major sources of data – the Parliamentary Constituency wise Election Data of 2019 General Elections recorded and published by the Election Commission of India and the FRA Potential of Parliamentary Constituencies which is based on the Census of India, 2011.

The assumptions made to calculate this minimum potential of FRA are as follows-

- a. Forest area lying only within the village boundaries is included and considered while computing the Minimum potential of forest area eligible for FRA.

The term 'Minimum Forest Area Eligible for FRA' has been used because only information on forest land recorded within the village revenue boundaries is available in the Census and has been used for the analysis. However, the provisions of FRA- the various rights provided in Section 3 and the authority vested with the Gram Sabha for governance of forests- apply to forests within and outside the village boundaries and extend over forest landscapes. So, the actual potential forest areas that come under the scope of FRA for forest rights recognition could be much more.

- b. All residents of villages having forest area within the village cadastral boundaries are deemed Forest Rights Holders, especially in the context of Community Forest Resource Rights, some of which are as follows:
  - i. Rights over Minor Forest Produce i.e. right of ownership, usage, access to collect and dispose, also including rights of *nistar*
  - ii. Rights to protect, conserve or manage any community forest resource being traditionally protected and managed.
  - iii. Rights to access biodiversity, and over intellectual property and traditional knowledge related to cultural biodiversity.
- c. To calculate an estimate of Electors who are eligible for forest rights recognition as per FRA, a ratio of 'No of Electors in India in 2019' divided by 'Population Estimate of India in 2019' has been used as proxy (which comes to 0.684185) and multiplied by the Population of Gram Sabhas eligible for FRA implementation. Therefore, for each Gram Sabha, the calculation is as follows -

$$\text{Estimate electors eligible for CFR} = \frac{\text{No of electors in 2019}}{\text{Estimate Population in 2019}} \times \text{Gram Sabha Population eligible for CFR}$$

Estimate electors eligible for CFR =  $\frac{\text{No of electors in 2019}}{\text{Estimate Population in 2019}}$  × Gram Sabha Population eligible for CFR

Estimate electors eligible for CFR = 0.684185 × Gram Sabha Population eligible for CFR

This calculation is necessary so as to calculate the percentage of electors to the total population, as a way to estimate the number of electors who can be possible FRA rights holders.

A similar formula as above has been used to calculate estimates of SC and ST electors eligible for CFR. Because a National Census was not performed after 2011, we have used an estimation of national population in 2019, which was drawn from the Projections made by the Government of India and released as part of the 2011 National Census Database. The national population of India

estimated for 2019 as per the projections was one billion three hundred thirty-two million nine hundred thousand (1332900000).

For this report, electors are people who are eligible to vote, and voters are those who have lodged their vote in the general elections of 2019.

### Categorisation of Parliamentary Constituencies

The parliamentary constituencies have been categorised in five categories as per the percentage of electors eligible for FRA as a potential influencing factor in the elections, namely Critical Value; High Value; Good Value; Medium Value and Marginal Value. The criteria for the same along with a simple break up are in the table below.

The assumption is that Parliamentary Constituencies falling in the first four categories i.e. Critical Value; High Value; Good Value and Medium Value have implementation of Forest Rights Act as a significant electoral issue and can influence the margin of votes in these constituencies. Together, for the purpose of this note, these constituencies are called Core FRA Constituencies. There are 153 total constituencies, compared to 143 such constituencies in the previous version.

Apart from these constituencies, there are 117 other constituencies where potential forest rights holders constitute about 10-20% of the electors, where while FRA may play an important role, it might not be an only or a significant issue to influence election results. For this note, these are called Marginal FRA Constituencies and have been excluded from Core FRA Constituencies.

## Forest Rights Act, 2006: A way to actional Constitutional Guarantees to the Adivasi and Other Tribal Forest Dwellers of India

The Constitution of India, amongst many things, requires the state to take steps to strengthen federalism, deepen democracy, promote people's participation and autonomy at multiple levels. These are well reflected in the text of the Constitution of India. For example, Article 40 requires the State to organise village panchayats and endow them with such powers and authority as may be necessary to enable them to function as self-government units. The 73rd and 74th Amendment to the Constitution provided a basic framework of decentralisation of powers to the Panchayati Raj / Municipal bodies at different levels. Article 244 allows for the administration of Scheduled Area and Tribal Areas as mentioned in the Fifth and Sixth Schedules of the Constitution as well as the Panchayat (Extension to the Scheduled Areas) Act, 1996 (PESA). The Autonomous District Councils constituted under the Sixth Schedule of the Constitution or those created through State enactments, and the Special Provisions in Article 370 A for Nagaland and 371 G in Mizoram are other such examples. The FRA, 2006 adopts the PESA format of empowerment of village self-rule and deepens and expands democracy and participatory self-governance beyond the Scheduled Areas, to cover forested regions, thus conferring a big leap in the expansion of participatory democracy across India (except Nagaland and Mizoram where customary and traditional village governance structures are legally recognised and vibrant). The FRA represents and advances community governance further and that must be politically affirmed and established.

This study intends to be one such effort – to map out an approximate potential using official sources of data, towards developing a tool for people's movements and activists to use in a pre-election period, to make demands of the people's representatives – including those in power and those in opposition. This process also underlines the importance of evidence-based advocacy and policy building to supplement, support and amplify what the Adivasi people and their leaders have been asking in various ways.

## Findings

The findings of the study indicate that Forest Rights can be seen in a scale of value from Critical Value (where FRA is most significant an issue) to Marginal Value (where FRA is of least significance as an issue) in the following number of Constituencies.

Of the 153 Core FRA Constituencies, the BJP won 103 seats, while the INC won just 11 seats. However, INC remains in the running in these 153 Constituencies, as it came in 2<sup>nd</sup> place in 79 out of the total 153 constituencies. Others won 39 seats of the 153 Core FRA Constituencies, mostly in Andhra Pradesh (5),

Maharashtra (10), Odisha (11), Telangana (5). The breakup of other parties who won in these seats is as below:

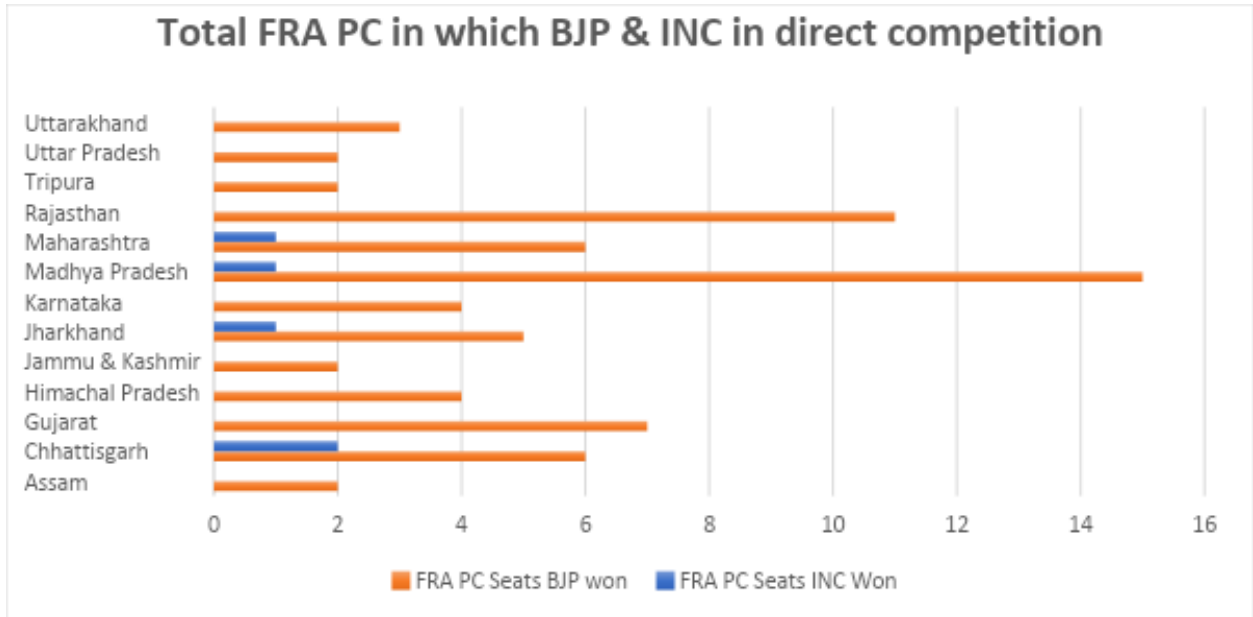
Thus, INC, which enacted the FRA, albeit under pressure from People's movement for tribal rights has performed quite poorly in PCs where FRA is a core issue, while they are runners up in as many as 79 out of the total 153 core FRA constituencies. BJP on the other hand outperformed INC and has won a majority of PCs where FRA is a significant issue. Out of the 153 Core FRA constituencies, INC and BJP ran directly against each other in as many as 74 Constituencies, of which INC won only 5.

A state wise breakup of the 74 Core FRA Constituencies where BJP and INC were running against each other is as follows:

## Parliamentary Constituencies Reserved for Scheduled Tribes (47)

There are 47 total ST reserved seats in India out of which 42 are Core FRA Constituencies. BJP won most of the ST seats in the 2019 elections and therefore its chances can be affected the most as FRA is a significant issue in these constituencies. The policy interventions by the central government, particularly the MOEFCC/Forest bureaucracy led efforts at diluting FRA through the series of legislative and policy changes such as Compensatory Afforestation Fund Act, the Draft National Forest Policy, changes in Land Acquisition, Rehabilitation and Resettlement Act as well as the recent amendments to Forest Conservation Act in 2023.

The details of PC seats reserved for STs which are core FRA constituencies are in the table below.

In PCs reserved for STs, issues of rights of the Adivasi communities become central in election campaigns for Political representatives for both – the current dispensation as well as the opposition. In a democratic framework, pre-electoral periods have thus been an opportunity for people's movements to highlight and advance issues to build a political discourse around rights-based movements. Thus, electoral candidates in ST reserved constituencies have a lot to gain by using the implementation of the FRA and land tenure rights as a core issue in Election Campaigning. In 2019, of the national parties, BJP won 31 (73.81%) and INC won only 3 (7.14%) out of a total of 42 Core FRA PCs reserved for STs.

The campaign issues for electoral candidates in Core FRA PCs reserved for STs would be effective implementation of FRA, especially community forest resource rights and empowerment

of Gram Sabhas, remedying mass rejection of forest rights claims and the threat of eviction from forest land, implementation of PESA, withdrawal of forest cases, effective price for MFPs etc.
