THIRTEENTHLY :- That you all Accused namely, Pragyasingh Chandrapalsingh Thakur @ Swami Purnachetnanand' Giri (Original Accused No.1), Ramesh Shivji Upadhyay (Original Accused No.4), Sameer Sharad Kulkarni (Original Accused No.5), Ajay Rahirkar (Original Accused No.6), Prasad Shrikant Purohit (Original Accused No.9), Sudhakar Dhar Dwivedi (Original Accused No.10), Sudhakar Chaturvedi (Original Accused No.11) along-with wanted absconding accused Ramchandra Kalsangra (wanted Original Accused No.13) and Sandeep Dange (wanted Original Accused No.14) abetted each other and hatched criminal conspiracy between January 2008 to October 2008 with a common object and with an intention & knowledge in order to spread the activities through 'Abhinav Bharat' Organization, to



And I do hereby direct you all be tried by me for the afore-said charges.



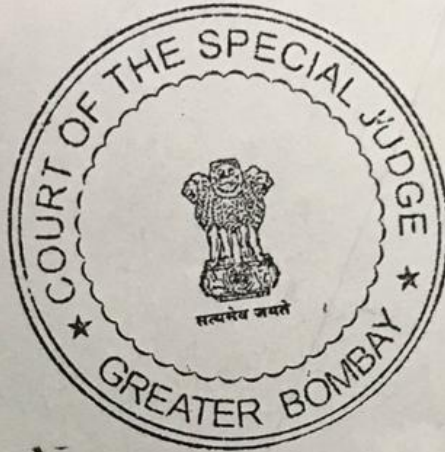
