# Instructions of the Collector & District Magistrate issued after CS Video Conference on COVID-19 on 29.03.2020

The Collector and District Magistrate, Ananthapuramu has issued following instructions after Chief Secretary Video Conference held on **29.03.2020** to the District Officers concerned. Also instructions have been issued to the Sub Collector, Penukonda, all the RDOs, Municipal Commissioners and all the Tahsildars through **Tele Conference**.

1. The Collector & District Magistrate has instructed PD DRDA and PD MEPMA to collect the details of **Stranded person's state-wise** i.e., Migrated Labour / Passengers who are held up in the district due to **lockdown** and submit to the Collector for onward submission to the Government by tomorrow morning.

## Action: PD DRDA/PD MEPMA

2. The PD, MEPMA and PD DRDA are made responsible for monitoring of providing relief operations to the **Stranded Migrant Labour / Passengers** at Urban and Rural areas respectively.

#### Action: PD DRDA/PD MEPMA

- 3. All the Municipal Commissioners have to **arrange for Shelters** for providing **food**, **drinking water** and other **amenities including sanitizers** to the Stranded Migrants at four or five places in Slums and other Colonies where poorer sections are living depending upon the size of ULB.
- 4. As per the instructions of the Government shops relating to **Essential Commodities**, **Groceries** and **Vegetables** etc., will be open from 6.00 AM to 11.00 AM in all urban areas from tomorrow onwards this shall be strictly maintained.

### Action: All the Municipal Commissioners

- 5. It is observed that Migration workers Stranded in Amadagur, Tanakal, Puttaparthi & Passengers in Guntakal Station and also in other mandals also. All the Tahsildars are instructed to open relief camps to the poorer sections if necessary and provide **Ration** or **cooked Food** by taking the support from the Charitable Institutions / Industries and with the assistance of Volunteers and funds will be claimed from the TR-27 if necessary advance amount will also be released.
- 6. For this purpose of providing **relief operations** Kalyanamandapams or Hostels may be identified.

#### Action: Sub Collector, Penukonda, All the RDOs & Tahsildars.

7. The District Medical & Health Officer is requested to give the details of 14 persons who come from Delhi after attending to religious programme by tomorrow morning and keep the **13 identified persons** in separate quarantine centers i.e., at CLRC Rapthadu. Samples have to be taken for diagnosis. The details of one person who gone to Hyderabad to be informed to the concerned officer. The PD DRDA has to make necessary arrangements for food and other arrangements at CLRC Rapthadu for these 13 identified persons.

#### Action: DM&HO and PD DRDA

- 8. The Employees details of forest department, NSS & NCC volunteers have to be obtained by tomorrow.
- 9. The DRO has to check one exclusive **DSP** is kept incharge in the District Control room to overall **monitoring of Lockdown issues, Transportation and Movement** etc., and issue proceedings accordingly.

#### **Action: DRO**

- 10. The DM&HO has to list out all the Medical and Paramedical staff including Private Hospitals and submit the report to the District Collector by tomorrow.
- 11.Tomorrow's training programme on Biomedical waste management to be conducted during the afternoon session from 2.00 pm onwards
- 12. Necessary arrangements have to be made for **Tele Medicine** to the People by tying up with Private Medical Institutions and workout the modalities for telemedicine operational in the district.

# Action: DM & HO

13. All the Municipal Commissioners have to identify the **hotspots and colour coding** and submit the report where the more number of foreign returnees are there.

## Action: DM & HO & All Municipal Commissioners

14 .Public Health needs to be proper care, hence District Panchayat Officer and CEO Zillaparishad shall make necessary arrangements for **continuation of Sanitation activities** happen in more vigorous manner by giving proper instructions to the MPDOs / Panchayat Secretaries and Volunteers

15. The Joint Collector-II and DM&HO has to make arrangements for identification of **5000 beds** including in private hospitals for the preparedness on COVID-19
