ORDER

A series of discussions were held with the representatives of Private Hospital Organizations to utilize the services of private healthcare institutions for effective management of COVID - 19 crisis in the State.

The Private Hospital Organizations informed that the existing AB -PMJAY/ KASP health benefit package :2.0 rates are not sufficient and the same needs to be revised for them to participate with the Government in COVID-19 management.

As per the reference read as Ist paper above the State Health Agency has recommended revised rates which can be made applicable to private hospitals for COVID19 management in Kerela. The Executive Director also requested to revise the circular read as 2nd paper above.

Government after examining the proposal hereby accord sanction to the following revised rates which will be applicable for private hospitals for COVID-19 management [Rs./per day] under KASP and also for the Government referred Patients in other Private Health care institutions.

General Ward	Rs.2300
HDU	Rs.3300
ICU without ventilator	Rs.6500
ICU with ventilator	Rs.11500

2. The existing PPE cost [Add on medical package] as per circular No.34/2019/SHA/KASP dated 04/05/2020 will be extra and as per existing norms of KASP.

3. Sanction is also accorded to the State Health Agency to revise its earlier circular regarding the rates with private hospitals and are also authorized to finalize the implementation guidelines in consultation with the private sector hospitals.

With regard to the execution of the packages, sufficient funds will be made available to State Health Agency.
